I am a Professor of Economics with expertise in the econometric modelling of consumer choice, firm supply, and the market outcomes from competition. I have used survey and market data to estimate demand, quality, pricing and profits for various media and telecommunications services and products. I have written twelve surveys with consumer choice experiments ("conjoint analysis") and three opinion-based surveys. The findings from these surveys have been published in eight peer-reviewed journals. More generally, I have published over 30 articles in numerous peer reviewed journals such as *The Review of Economics and Statistics, The Journal of Industrial Economics, Review of Industrial Organization, Journal of Applied Economics, International Journal of Industrial Organization, Journal of Law and Economics and Journal of Regulatory Economics.*

Since 2014 I have provided expert opinion in four patent litigation cases. In these cases, I used choice experiments (administered by survey) and market data to estimate oligopoly models of the demand and supply of smartphones. I used the estimated parameters from these models to infer consumer and firm valuations for various patented technologies that enhance smartphone functionality and usage. I have provided depositions in two cases and successfully demonstrated to the judges that my methodology and reasoning were scientifically valid and could be applied to the facts of the cases. The remaining two cases were settled prior to Daubert Challenges and court proceedings.
