Research Emphasis

I am an ethnographer of communication who studies the relationship between culture, communication, and mobility. My empirical research focuses on the ways communication facilitates the movement of discursive resources across cultural boundaries. I am particularly interested in how speakers assign various kinds of value to discursive resources, and what role value has to play in the global circulation of speech genres such as Anglo-American public speaking and metadiscursive terms such as "hate speech" and "communication." My current ethnographic research project investigates how public speaking is communicatively constituted as a mobile speech genre in the undergraduate public speaking course. This research creates opportunities for advancing theories of value, cultural discourse, speech community, and speech economy.
