Manuscripts in Progress:

Paranoia and the Totalitarian Drift of Modernity (book-manuscript, expected date of completion: Winter 2023).

This book-length study investigates the history of paranoia considering the re-emergence and rise of sovereign forms of authority in Weimar Germany. Clinically characterized as mental delusion of persecution, jealousy, and grandeur, paranoia became popular in modern psychiatry around 1900 and took on special importance in Freud’s psychoanalysis. Against this historical-epistemological background and informed by philosophical explanations of paranoia as “an illness of power” (Elias Canetti), my study develops an understanding of paranoia as a theoretical figure offering a critical response to two of the central crises of modernity: the crisis of reality and truth; and the crisis of authority. Based on empirically rich case studies from literary (Franz Kafka’s novels), sociological (Siegfried Kracauer’s panoramas), psychiatric (Robert Gaupp’s case of Ernst August Wagner), and journalistic (Leo Lania’s report on the Hitler-Ludendorff trial) contexts during the Weimar era, my book analyzes the shifting of the forces of modernity toward totalitarian forms of power and control.

Against the background of literary traditions of authorship and intellectual responsibility, this book discusses the critical project that the contemporary German author, Rainald Goetz, promotes in his literary

oeuvre. Goetz's work has been recognized by some of the most prestigious literary prizes in Germany for having experimented with various media and contemporary forms of expression to analyze our current and contemporary reality. Deeply invested in attempting a literary expression of the present, his work is pervaded by autobiographical references, draws heavily on his own experience, and is rooted deeply in contemporary German cultural, societal, political, and journalistic realities. Known particularly for having inaugurated a German version of pop-literature, my readings in this book show that Goetz's work must also be seen in a humanist tradition and follows a critical project that positions his work in a more classical canon of authors and thinkers such as Johann Wolfgang von Goethe, Georg Büchner, Gottfried Keller, and Friedrich Nietzsche.
