Ever since working as a teacher in the Congo in the late 1970's, I have sought to understand the optimal conditions for development. Prior to working at the University of Washington's Social Development Research Group, I focused on prosocial development, cognitive development, motivation, and the qualitative aspects of performance. While at Brandeis University and Wellesley College, I adopted a systems-oriented, social-developmental, life-span approach.

During the ensuing twenty-three years at the University of Washington as project director, investigator and PI on the Seattle Social Development Project, and ten years as PI of the SSDP Intergenerational Project (The Intergenerational Influence of Substance Use on Children, NIDA, R01 DA12138) my work focused on understanding development and consequences of antisocial behaviors such as violent and non-violent delinquency, crime, and gang membership, drug use and dependence, and the mechanisms of continuity and discontinuity in these behaviors across generations. Additionally, I led a NIDA-funded study to examine *gene-environment interplay in the development of alcohol and tobacco addiction and related problems*. This research endeavor was implemented through a multidisciplinary team in collaboration with Matthew McGue and William lacono and others at the Minnesota Center for Twin and Family Research, and sought to understand the relationship of social and genetic vulnerabilities that may determine addiction and related behaviors from adolescence through adulthood.

As the current Director of the *Prevention Science Program* (formerly *Problem Behavior and Positive Youth Development Program*) at CU, Boulder I have sought to enhance collaboration within and beyond the Program, and to engage in Program-wide strategic planning to lay down a blueprint for the next five years of our work. My own research efforts continue to focus on the prevention of tobacco addiction, particularly among marginalized populations. I continue to ask: What are optimal family, peer, school and community environments that encourage healthy youth and adult development? And How do we work with communities to make this happen?

Testing the Efficacy of Botvin's High School LifeSkills Training Program. Co-Principal Investigator. (Arnold Ventures). This study will provide an independent, rigorous cluster-randomized controlled trial with 55 high schools in Colorado and Ohio to test the efficacy of *Botvin's High School LifeSkills Training* in reducing (primary) tobacco and cannabis use over time, as well as (secondary targets) alcohol use, illicit drug use, violence, mental health and academic achievement. Assessments will be at baseline, immediate posttest, 1-year follow-up and 21-month follow-up. *Botvin's LifeSkills Training* (LST) is a classroom-based substance abuse prevention program designed to prevent teenage tobacco use, drug and alcohol abuse, violence and other risk behaviors by teaching students self-management skills, social skills, and drug awareness and resistance skills. Currently, the middle school (grades 6-8) version of LST has strong evidentiary support in reducing tobacco use and related problems. However, the much briefer high school (grade 9 or 10) version of LST has only limited, though promising, positive evidence for reducing high school adolescent substance use. Total cost: \$1,973,557. 1 July 2020 to 31 March 2025.

Empowering Youth to Realize Equity and Prevent Violence: Youth Violence Prevention Center-Denver, Co-Principal Investigator. (Centers for Disease Control, Beverly Kingston PI). Administered through the Center for the Study and Prevention of Violence at CU Boulder, this project establishes and maintains the Youth Violence Prevention Center — Denver (YVPC-D) which partners with local community organizations in Denver's Far Northeast and Park Hill communities to identify, implement, and evaluate community-wide strategies that create safe, supportive environments for all young people. \$1,199,927. July 2021- June 2025.

The Intergenerational Transmission of Parenting and Self-Regulation Following a Universal Preventive Intervention in Childhood. Investigator. (R01; NICHD, Sara Burr Johnson and Rashelle Musci, PIs, Johns Hopkins Univ, School of Public Health). This three-generation study seeks to determine whether self-regulation in childhood is a foundation for parenting in adulthood and whether a successful universal preventive intervention to improve self-regulation in childhood also improves self-regulation in the next generation. Total costs: \$4,089,815. July 2019-August 2024.

Blueprints for Healthy Youth Development Advocacy Initiative. Co- Principal Investigator (Arnold Ventures). Blueprints for Healthy Youth Development provides a registry of evidence-based positive youth development programs designed to promote the health and well-being of children and teens. We review the available evidence of prevention programs (over 1,500 reviewed to date) to determine those that meet the "tested and effective" standard. These programs will help young people reach their full potential by promoting positive youth development such as academic performance and success, emotional well-being, positive relationships, and physical health, and by helping young people to overcome challenges associated with violence, delinquency, and substance abuse. This project supports Arnold Venture's Evidence-Based Initiative by promoting interventions that show evidence of improving policy-important outcomes over a sustained period of time. To do this, we are pursuing three primary activities. (1) Provide a trusted source of accessible information on experimentally proven interventions recommended for large-scale implementation that meet a high evidentiary standard by supporting the Blueprints' rigorous systematic review process, website, and other targeted marketing efforts. (2) Expand Blueprints' methods for communicating important findings on effective interventions by updating the process for synthesizing Blueprints model and model plus programs (i.e., interventions that are ready for wide-scale adoption), and corresponding language, to reflect how much the intervention will "move the needle" in terms of impacting important policy outcomes. And (3) Enhance Blueprints' advocacy efforts in implementing systems that prevent social problems by influencing decision-makers (e.g., legislators, funders, agency directors, etc.), practitioners, and the general community to direct resources toward, scale and sustain behavioral interventions that are backed by sound research. (\$1,998,675 in total costs over 3 years, July 2022, June 2025).

Under Review

A Multisite Effectiveness-Implementation Trial of a Parent-Adolescent Intervention to Reduce College Student Substance Use and Related Problem Behaviors. Co-Investigator (R01-NIDA). This proposed study tests the Letting Go and Staying Connected intervention, the first theory-based, interactive, self-administered handbook designed to prevent or reduce adolescent substance use and related risk behaviors and increase academic success and other positive developmental outcomes. An RCT established program efficacy—students in the intervention condition (vs. control) were less likely to initiate or increase substance use during their first semester in college (ORs=.45 to .73). However, this trial was based on a homogeneous sample of mostly White students living on campus in a single rural setting, did not explicitly test outcomes beyond substance use, include Spanish language materials, or assess both parent- and university-level implementation outcomes. Thus, it remains unknown if this intervention is generalizable across more diverse student populations and university settings, and across broader health and academic outcomes. (Submitted, NIDA, Total Costs requested: \$2,990,960)

Testing cross-generational effects of the Raising Healthy Children intervention. Investigator. (R01 – NIDA). This three year R01 project will analyze existing prospective data linking 2 generations from SSDP and the SSDP Intergenerational Project (SSDP-TIP) to test (Aim 1) the long-term effects of the RHC intervention through age 42 on SSDP participants who became parents, (Aim 2) to test cross-generational effects of the intervention among offspring during adolescence (ages 12-18) and young adulthood (ages 18-25), and (Aim 3) to test hypothesized mechanisms of cross-generational intervention effects. (Submitted to NIDA, Total costs requested: \$915,777.)

Total cost: \$2,797,039. Dec 2015 Dec 2019.
- Gene-Environment Interplay in the Development of Drug Abuse, HIV Sexual Risk Behavior and Comorbid Problems. Principal Investigator. (R01; National Institute on Drug Abuse, grant #DA024411 01-07). Tobacco and alcohol abuse and dependence are leading preventable causes of disease and death in the United States. Vulnerability to develop tobacco and alcohol dependence and comorbid problems is influenced by a combination of environmental and genetic factors. This study began with two years of initial ARRA (stimulus) support, and subsequently another five years of support to examine how genes and environment work together in affecting the development of tobacco and alcohol addiction and related problems in adulthood.
