  - Collection contained some rare early printings of spiritualist and theosophist manuscripts.
  - However, the collection also contained a number of common books as well as some audiovisual materials for which the copyrights could not be obtained, all of which were deaccessioned.
- Intellectually and physically arranged collection materials.

- Crafted item- and folder- level inventories in ArchivesSpace.
- Identified and resolved potential preservation issues within the collection's audiovisual materials.
  - For this collection, audiovisual materials mostly consisted of photographs. Some of these photographs had been damaged either by the elements or aging in less-than-ideal preservation conditions.
- Strengthened relationship between institution and donor with deep collection engagement and conversation throughout processing.
  - I take great pride in my ability to find the middle ground between serving a donor's wishes and serving the best interest of researchers and our institutions. For this collection, I spoke extensively with the donor due to the traumatic nature of some materials in order to best understand how to make these materials accessible yet safe for researchers, while also honoring the donor's vision for the collection which was of course deeply personal to her.

**Jacobs Collection Temporary Processing Assistant** CU Boulder Archives Ken and Flo Jacobs Collection, May 2022 - January 2023

- Rehoused materials from their initial state at accession.
  - These materials arrived almost entirely unarranged. Some papers were placed by donors into preliminary folders based on particular events such as "New York Film Festival 2010," but these folders did not contain all relevant collection materials. Most materials arrived in unsorted piles from the Jacobs' home.
- Assessed materials for rarity and deaccession.
- Intellectually and physically arranged materials.
- Crafted folder-level inventories in ArchivesSpace.
- Redacted Private and Personally Identifiable Information from hundreds of documents in accordance with state and federal law (CORA, HIPAA, FERPA.)
- Drafted language and crafted policy surrounding sensitive language and difficult discussions found in the collections' digitized audio materials.
- Identified and resolved potential preservation issues within the collections' audiovisual materials.
  - My work in this case centered around audio preservation, many recordings arrived in less-than-ideal conditions and therefore upon digitization contained static interference. I provided crucial metadata for these recordings in order to make them accessible and available to researchers.
- Fostered donor relations through continual updates on processing, and visiting the donors' family home in Manhattan.
- Organized and conducted oral histories with the donor and family members in order to bridge gaps in collection materials' context and content.
- Utilized professional best practices as outlined in "Describing Archives: A Content Standard."

• Rehoused materials from their initial state at accession.

- Materials were very loosely pre-arranged by the donor before accession and were housed in non-archival folders in cardboard boxes.
- Assessed materials for rarity and deaccession.
  - In this case, I redacted and deaccessioned medical documents which the donor had taken important collection-relevant notes on, as well as some published works sent along to provide the archivist context for collection materials.
- Intellectually and physically arranged materials.
- Crafted folder- level inventories in ArchivesSpace.
- Supported and appraised new acquisitions into the collection.
- Redacted documents for Private and Personally Identifiable Information in accordance with state and federal law (CORA, HIPAA, FERPA.)
- Identified and resolved potential preservation issues within the collections' paper and audiovisual materials.
  - These issues mainly manifested in physical breaks and cracks in the collection's videocassettes, and residue left on materials from earlier storage.

  - Included videocassettes (VHS and MiniDV,) DATs, cassette tapes, CDs, DVDs, film reels, and floppy disks.
