In my full-time appointments in two writing programs at the University of Colorado, I have taught seven to nine sections per year of upper and lower division courses. Though I have taught mainly 3020 and 1150 classes, I have also taught 1250, 3040 and 2020 courses. In 3020, Topics in Writing, I have designed and taught classes in American Short Stories, Steinbeck, Hemingway, and Stories in American Culture. In 2008, I created and taught a course, The Rhetorics of Faith and Doubt, for the Center for the Humanities and the Arts; though it was taught through the Farrand Academic Program, I represented the PWR in teaching the course—one of the only two to be selected by the

CHA for that year's theme, "Faith, Reason, Doubt." For my courses, I have created and revised several versions of course packets (now D2L materials). I prepared and revised course policies and lesson plans—assignments, supplemental writing texts, and writing examples. I led daily workshops, evaluated student essays, and determined final grades. Lastly, I have written dozens of letters of recommendation for students and faculty.
