A month-long course taught by the Learning Design Group Instructional Designers. Course prepared participants to develop and teach online courses by providing instruction on key pedagogical skills, tools, and technologies.

Humanizing Online Teaching Symposium, sponsored by the Assembly for Expanded Perspectives on Learning, July 22, 2020

A one-day symposium on that emphasized the interpersonal and affective dimensions of online teaching, cultivating resilience, teaching for equity and social justice, and creating inclusive learning environments, with attention to the conditions created by the ongoing pandemic.

ASSETT Summer Course Design Workshop, May 18-22, 2020

A comprehensive introduction to developing a range of technology-enhanced learning experiences. Emphasized transitioning from face-to-face teaching to remote delivery, providing a foundation of pedagogy, technical skills, and research-informed practices that can be used to support fully online courses, hybrid offerings, and remote teaching.

Boulder District Attorney's Office Restorative Justice Training, July 2019

A training on theory and practice of restorative justice to prepare participants to volunteer in DARJ Community Group Conferences.

Youth Mental Health First Aid, offered through Boulder Valley School District, January 2018

An 8-hour course that teaches adults who regularly interact with young people how to identify, understand, and respond to signs of mental illnesses and substance use disorders and to provide initial help and support to adolescents who are experiencing mental health or addictions challenges or are in crisis.

CU Restorative Justice Program, July 2014 – Present

CURJ serves as an alternative to the traditional disciplinary systems in Boulder and at CU. Restorative Justice helps to address the relationship between victims, offenders, and the community in a way that repairs the impacts of an incident, holds the offender accountable for their actions, and builds community. I participate in conferences designed to help someone who has committed a crime understand how their actions affect others and develop a plan to repair harms caused by their actions.

DARJ provide alternative responses to crime and conflict. I volunteer as a participant in restorative justice conferences. In these conferences, victims and harmed individuals, community members, and family members are empowered to join in a facilitated restorative justice process that supports the person who committed the crime to take meaningful responsibility and repair the harm created by their actions.

Focus Reentry is a program designed to reduce recidivism and enhance community safety by assigning mentors to individuals who are newly released from the Boulder County Jail to serve as a bridge in the transition back into society.
