Advanced Natural Resources Field Seminar: The Colorado Plateau

University of Colorado Law School

- Manage the training and caseload of 80 students and their supervising attorneys as they provide *pro bono* legal services to Hispano irrigators in Southern Colorado regarding their land, water, and communal natural resources rights. Direct applied policy research, education outreach, and advocacy to advance the interests of our client community in state and federal policies affecting water and land use. Supervise groups of 2-5 students representing clients, conducting research, or doing policy work.
 - Awarded the American Bar Association’s Distinguished Achievement in Environmental Law and Policy Award, the highest award for an organization, for the Project’s extensive successes in achieving environmental justice and training new attorneys and policy advocates.
 - Secured \$50,000 donation to support the Director position.
